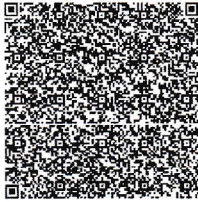

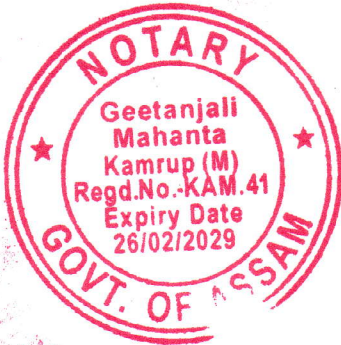

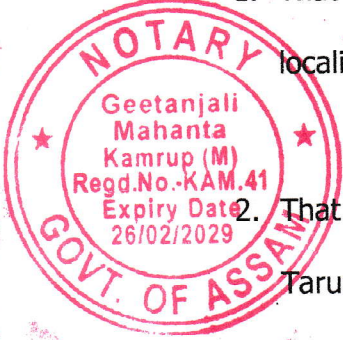
1. That I am a citizen of India by birth and permanent resident of aforesaid locality.
